City Council Meeting

Wednesday January 10, 2024

The City of Bromley met in regular session on Wednesday January 10, 2024, with a pledge to the flag and mayor Denham presiding.

Roll Call- The following members were present: Mike Kendall, Tim Wartman, Dave Radford, Andy Clift, Gail Smith. ABSENT- Dianne Wartman

Call to order- Staff present- Kim Vocke City Attorney, Chief of Police Cody Stanley, Fire Chief Mike Steward, Public Works Bob France, City Clerk Brittany Hinzman.

Approval of Minutes- Motion to approve first, Mike Kendall, Andy Clift second, all in favor YES.

Citizen Report – Keith Williams, “is there going to be a return to the city of 30k on the wall project on MOORE St.? Mike Kendall- YES.

PDS- Gail Smith- 3 Boone Street, junk still in yard, 7 Shelby – both have gone to enforcement board, and a second letter needs to be sent out, how should we proceed? Suggesting second letter citation. Two new cases 13 Boone, roof of garage is going to collapse, 431 River Rd VACANT? Grant money available for street trees, option to apply for grants for trees on behalf of the city, Cassandra from URBAN CANOPY. Needs to be submitted by end of January. Will respond with interest.

Police Chief- full report available upon request, Gail Smith inquiring about CONTRACT ends DEC 31st, voted to extend current contract until 2027. Kim Vocke suggesting a signed contract. Per Chief potential lowering of fee up to 20k. Mike Kendall – need to provide a chance to LUDLOW police to see if lower price is an option. Gail Smith, motion to create and bind contract with Park Hills Police, JULY 1, 2024- JUNE 30, 2027, until fiscal year 2027, Dave Radford second, all in favor, YES.

Fire Chief- full report available upon request.

Hall Committee- Dianne Wartman ABSENT Mayor going to inquire about updates to council chambers and begin bidding for remodels.

Roads- Dave Radford- awaiting finalization of street light replacement, all documentation complete for engineering fees, and LOCKARD contract.

Public Works- Bob France n/a

Kim Vocke- Spectrum franchise agreement filed, second reading of ORD NO- 12-1-23, new section to amplified sound and fireworks, motion to accept Gail Smith first, Mike Kendall second, all in favor, YES. Second reading of ORD NO- 12-2-23- new section re: mobile food

vending. Andy Clift motion to accept first, Gail Smith second, all in favor, YES. Second reading of ORD NO- 12-3-23 to close public way 115 Moore St. Motion to approve Mike Kendall, first, Andy Clift second, roll call, 3 yes 1 no Gail Smith. Can we edit ordinance so that the Mayor's approval is required prior to the engineering firm engaging with a resident, and also to require all fees associated with the engineering projects be paid for per the resident who submits the work order? To be addressed.

Ways and means- Budget request forms for new year, RAISE grant re: 50% for SOUTHBANK project. Mural budget appears short, Gail smith, I need 19k. Treasurer to add to capital budget account. Gen fund showing 161k expense is being transferred to Capital Improvements, but is appearing as debit. If it is being transferred it should be reflected as a credit. The transaction in the Capital Improvement account is showing the entry as an income entry and not an expense.

Park and Playground- Tim Wartman was able to get ahold of the crew for fencing for grass to be removed and cleaned up. Bob France- signs for park closing to be installed in next couple weeks. "SUNSET TO SUNRISE".

Insurance and grants- Andy Clift exploring potential grants for 2024.

Mayor reports- Please be certain to make me aware of budget needs and committee needs to assure we have all items covered in the budget.

Committee reports- Motion to approve first, Gail Smith, Dave Radford second, all in favor YES.

Old business- Gail Smith- RE; Cemetery trees and overgrowth, DUKE will remove trees in the spring, (April, May) trees to be cut out of wires, in the meantime they recommend no one be in that area. Mike Kendall has finalized documentation for the city to receive 75k reimbursement from the STATE of KY.
