City Council Meeting

February 12, 2025

The City of Bromley met in regular session on Wednesday February 12, 2025, with a pledge to the flag and Mayor Denham presiding.

Roll Call- The following members were present: Mike Kendall, Tim Wartman, Dave Radford, Kelly Dudley, Dianne Wartman, Andy Clift.

Call to order- Staff present- Park Hills Police, Sargeant Brian DeWaine, Fire Chief Mike Steward, Public Works, Jack Dudley, City Clerk Brittany Hinzman.

Approval of Minutes- Motion to approve minutes, Mike Kendall first, Andy Clift second, all in favor, yes.

Citizen Report – Eric France- the hall that is rented is cluttered and bleak. Could the council put some effort into maybe a working TV? Maybe fresh paint? Make it nicer and more welcoming? Mayor- Dianne could investigate how best to go about this. Find out what we are not using down there? If it's junk, we can get rid of it or out it up for auction, we just need to be sure to follow due process.

PDS- Andy Clift- I will be attending the meeting for new council members.

Police Chief-Brian Dewaine, full report available upon request.

Fire Chief- Mike Steward- full report available upon request.

Hall Committee- Dianne Wartman- the water leak has stopped. Can we get the city building surveyed, so we know what we must work with? Tony mentioned the drainage. Mayor- I will get you the information for our surveyor. Also please investigate TBNK coming in for recording of our meetings.

Roads- Dave Radford- Trying to keep the streets clear. This last snow was the most we have had in many years. They did pop a portion of the speed bump up out of ROHMAN, so Jack can get together a PO for ordering replacements. Rt 8 veteran banner hanging per DUKE is permitted, however I would like to have that in writing prior to installment. There are 13 more available.

Public Works- Jack Dudley n/a, mayor- please keep an eye on the food pantry to be sure it's clean and things aren't exploding in colder temps.

Ways and means- Mike Kendall- Revenue for general fund we are at about 70% approx. \$266k. Taxes being paid early is helping. Expenses are at 68%. Road fund we have received 47K to date.

We spent \$5,175 on snow removal plus salt with the heavy snow event. We have finally received the check for \$75k from the state. Please have budgets submitted by April 1st

Park and Playground- Tim Wartman – To get with Brian re: new bleacher seats, be it aluminum or new wood. We are pricing to see what may work best.

Insurance and grants- Kelly Dudley- Mayor- Kelly is going to oversee city events like our parade.

Mayor reports- Andy Clift appointed to PDS as alternate, Dianne Wartman motion first, Kendall second, all in favor. Yes. Bob France provided with reward.

Committee reports- Andy Motion to approve reports first Andy Clift, Dave Radford second, all in favor, yes.

New business Andy Clift, council member Kelly Dudley and I met in Southgate for new members to council, and Mike Kendall and I met with SD1 on January 13th for potential acquisition behind SD1 for boat ramps, they have agreed to a 40-year lease, and I have submitted the application to the state for fish and wildlife. Mike Kendall- we also tried to find the status of the availability of the rest of the land down the road, but we will have to wait, due to some EPA agreements. They have, however, committed to us that when it is released, we are first in line to decide. With the new zoning developments, it has been prepped along the whole riverfront for new development.
