#### **Citizen Report – No Report**

**PDS – Andrew Clift – Meeting held on the 27<sup>th</sup> of February. The city currently has 10 active cases with 3 new reported all three due to rubbish. Property at 305 Main Street is a total mess. Since all Property Liens have been satisfied, it is now in the hands of the city to initiate demolition. A short discussion on the report that the property has been sold recently has resulted in Mr. Matt Woods, our new attorney will check into this issue and bring it back to council.**

**Police Report – Sargeant Briane DeWaine reported that an issue was dealt with within the limits of the city where a uber driver coming from the Buffalo Bar was robbed by handgun and forced to be driven to the perpetrators home where the handgun was discharged. No one was injured and the issue is now under investigation.**

**Fire Report – Chief Mike Steward reported that his report was forwarded earlier and that they are continuing to work with BP pertaining to a water line replacement which will soon be finished.**

**Hall Committee – Dianne Wartman reported that she is obtaining on estimates for improvements in the downstairs hall discussed at last meeting and should have them soon. She is also getting estimates from gutter companies for cleaning. Hope to have that soon as well.**

**Attorney Report – Mr. Matt Woods, our new attorney, introduced himself to the council. He reported that he is currently obtaining and reviewing all the city files from Mr. Kim Vocke's office to come up to speed on past issues he was dealing with.**

**Parks and Playground – Dianne Wartman reported that the wood benches are in and look great. Waiting on the blacktop company to begin the work on the pickleball court. The mayor asked to check on the condition of the dogwood tree at the memorial. It does not look good and may need to be replaced.**

**Insurance – Kelly Dudley reported that all the paperwork has been submitted and she is meeting with Jessica soon to get more information for this position. She reported that the first meeting on the Memorial Day parade will take place soon.**

**Mayor's Report – Mayor Denham made a couple more comments about our new attorney. Mike Kendall reported that Matt has an assistant paralegal in his office that has experience with municipal processes and procedures, and she will be a great resource for us.**
